

Privacy	Policy

The MUVE Friend Card is a membership card that allows free and unlimited access to the permanent collections of the Fondazione Musei Civici di Venezia, invitations to all the openings of temporary exhibitions (and reduced tickets to visit exhibitions with an entrance fee), the possibility to participate in special events organized only for MUVE Friends and updates on the ongoing and planned activities of the Fondazione Musei Civici di Venezia. The activities, exclusive events and invitations are communicated to MUVE Friend Card holders by e-mail or paper mail, as are further benefits and advantages reserved only for the members of the program.

Pursuant to Article 13 of EU Regulation 679/2016 ("GDPR"), we would like to inform you that:

1. The data you provide will be processed only with your consent for the provision of services related to the Muve Friend Card and information relating to the institutional activities of the Fondazione Musei Civici di Venezia, as well as for the identification of the holder by the staff of the Foundation. It will be stored for the time necessary to provide the requested service and for the related legal obligations.

2. The provision of personal information marked with an asterisk is optional (first name, surname, date of birth, permanent address, e-mail), however failure to provide such data will make it impossible to for us to issue the Muve Friend Card and therefore you will be unable to benefit from exclusive services reserved for members.

3. The data is processed by personnel specifically authorized by the Foundation; the data will not be disclosed to third parties and will not be disseminated. The data will not be the subject of any automated decision-making or profiling nor will it be transferred outside the country or to international organizations.

4. The data controller is Fondazione Musei Civici di Venezia, with registered office in Venezia San Marco n. 52 - email address muvecard@fmcvenezia.it. The Data Protection Officer is the Organizing Secretary.

5. Under articles 15 et seq. of Regulation (EU) 679/2016, as the data subject you are entitled to obtain from the controller confirmation as to whether or not personal data concerning you is being processed, and, where that is the case, access the personal data to verify its accuracy or request its integration, updating, rectification, cancellation or to request the limitation of the processing of such personal data or express opposition to the processing and request portability. You can exercise these rights without any formal procedure, simply by writing to muvecard@fmcvenezia.it. If you consider that in connection with the processing of personal data relating to you there is an infringement of the GDPR, you have the right to lodge a complaint with a European Supervisory Authority, in particular one of the place where you normally reside, work or where the alleged violation has occurred. The Italian supervisory authority is Garante per la Protezione dei Dati, the Data Protection Authority.

By signing, you consent to the processing of your personal data for the purposes outlined in the privacy policy. You can withdraw your consent at any time.
